My Brother Knights and Sisters in Christ,

The end of this month we begin the Season of Lent, a time for contemplation, reflection, penance, and almsgiving. For many Councils it is also the season of Fish Dinner Fundraisers. I appreciate the invitations that I have received to attend some of these council dinners. I will attempt to make a few. I ask that you consider donating the proceeds of one or more of your dinners to the PA Special Olympics.

Last year, we partnered with the Special Olympics to assist them with their year-round training and competition in a variety of Olympic-type sports for children and adults with intellectual disabilities. Many of our council members participate as volunteers.

Every council can participate by conducting fund raising activities to help fund this great organization. So far, the amount we have collected is significantly below our past years donations for ARC. Although the 'Measure-Up Campaign' is gone, we should not stop the successful fundraising we have done in the past. It doesn't matter how your council comes up with a donation or what is the amount that your raise. It only matters that you give.

Hopefully, your Grand Knights and council officers have attended their district meetings. Much of the information that your District Deputy received at the Mid-Year Meeting is available on the state website and phone application.

I'm pleased by the response to the new ceremonial which was initiated in mid-January. Many councils have transitioned to the new degree and almost half or more of the candidates are First and Second Degree members who advanced to their Third Degree. The majority of these degrees have been conducted in church, which adds to the dignity of the ceremony. Be sure that you advertise your degrees and invite your wives and non-members to attend them. It is a great way for them to learn about the Knights of Columbus and why the work that we do is so important.

The last weekend of March marks the 138th anniversary of the establishment of the Order. I can think of no better way to honor our founder and continue his vision than to welcome a Catholic man into the Order. Your council should be working now to conduct the new Charity, Unity, Fraternity Degree during the last week of March. Follow the Delta Church Drive format and you are **guaranteed** to have at least three new members. I challenge every council to bring in at least three new members sometime that week, especially the 244 active council which have not brought in a single new member this year.

THE SEASONS OF LENT

In the Spring of every year the Catholic Church along with many of the major Protestant Churches celebrate Lent. Celebrate seems to be an odd word to use in referencing a season of prayer, fasting and penance, but read on and see if it makes sense.

Lent is a season when we take the time to confront our sinfulness, our mortality, and thanking God the Father for the gift of salvation through the Life, death and resurrection of Jesus Christ. The Word Lent comes from an Anglo Saxon term “Lencten”, recalling the lengthening of days. It translates to “spring”. Remember we celebrated Christmas in the darkest time of the year, now we celebrate Easter in the brightest time.

The season begins on Ash Wednesday and ends with the celebration of Holy Thursday, Good Friday, Holy Saturday and Easter Sunday.

What do we do during the season? The church encourages us by prayer, fasting, and abstinence to confront our sinfulness. We fast abstain on Ash Wednesday and Good Friday and we abstain from meat on the Fridays of Lent. Most of us also give up something for Lent like candy, smoking, alcohol, or something else. There is nothing wrong with doing these things though sometime doing these things, can make one difficult to live with. I would like to suggest something different – do something positive! Volunteer at a soup kitchen or a homeless shelter one or two times a week. Make a Holy Hour once a week, go to daily Mass, say the Rosary.

These and other prayerful things will help make Lent a positive experience. You can still do the traditional things, the candy, smoking, etc. If you should have the urge to do something really hard, how about this – turn off the cell phone for a few hours each day, now that would be a sacrifice for a lot of us. Another good idea is to do one or more of these things as a family.

Whatever you do, do all you can to make Lent a positive experience. I wish you and your families a Happy Lent that brings you closer to Jesus and a Happy Easter.

LEGISLATIVE UPDATE

In the past few months, the Pennsylvania General Assembly has been considering legislation of interest to the Knights of Columbus. One such bill is the **Buyer Beware Act (Senate Bill 60)**, sponsored by Senator Kristin Phillips-Hill), which enhances penalties on human traffickers and those who benefit from the illicit trade. Representative Seth Grove, who sponsored a similar bill in the House, was instrumental in gathering broad, bi-partisan support for the legislation. The bill was signed into law by Governor Wolf on February 5, and is now Act 1 of 2020.

Another bill which we are closely monitoring is the **Telemedicine bill (Senate Bill 857)**, sponsored by Senator Elder Vogel), which creates video-conferencing capabilities for certain doctor visits. The program is quite popular, especially in rural areas, where access to a primary physician may be limited. While the bill enjoys wide support, certain groups pushed to include the dispensation of medical abortions (utilizing dangerous drugs such as *Mifeprex*, which is strictly regulated by the FDA REMS list, a drug safety protocol). This provision was successfully taken out during the legislative process, and currently is up for a concurrence vote in the Senate. At this time, the bill's fate remains unclear.

With our present and upcoming efforts to promote good public policy, it becomes necessary to ensure that we are acting within proper boundaries (i.e. engaging in issue-specific discussions, avoiding candidate endorsement, etc.), so that we do not endanger our non-profit status. To that end, the Pennsylvania State Council has partnered with Commonwealth Compliance Solutions, a highly-regarded, Harrisburg-based firm, to handle these complex compliance matters.

FATHER GILBERT STRAUB COUNCIL CONDUCTS NEW DEGREE





If your Council is not participating in the Program, you should ask your Grand Knight to start. It is the right thing to do and it is easy.

Special Olympics Winter Games

On the chilly evening of February 9th, I attended the Winter Games of Special Olympics at Seven Springs Resort. This was an evening to remember and it speaks to the importance of our State Knights of Columbus Mission to support Special Olympics of Pa at the State Level.

After a nearly 200 mile journey from the Erie area, we pulled into Seven Springs Resort, close to the West Virginia line. We quickly found our room for the evening and readied for the Olympic Reception. We met Jack Rosati and Mike Lynch and then attended the Olympic Reception with State Deputy Mark Jago and his lovely wife Janis. There were many representatives from all of the agencies that support Special Olympics of Pennsylvania (SOPA) including numerous Law Enforcement Agencies from Pittsburgh and all across Southwest Pa.

Numerous Corporate Benefactors stood and spoke, congratulating Special Olympics on their 50th Anniversary including the Allegheny Health Network and Sheetz Convenience Stores. Donation Checks came from many Benefactors and Special Olympics received well over ½ million in cash and services during the reception.

After the hour long reception, the guests and the Athletes moved outdoors to the hillside plaza at the base of the ski slopes for the Opening Ceremonies. There were several speeches commemorating the athletes and again congratulating Special Olympics on it's 50th Anniversary. The Knights of Columbus had the honor of providing a Color Corps Flag Unit to Present Colors. The Flag Unit was led by Master Mike Lynch and was comprised of members from the metropolitan Pittsburgh area as well as Johnstown Pa. I was definitely proud to be a Knight that evening. As the Color Corps stood at Attention, the athletes began to parade in – county by county- over 350 athletes in all. Each county group had their own minute in the limelight on the plaza while the Olympic hymn played over the loudspeakers. After all of the county groups paraded in, there were additional groups of athletes from West Virginia, Virginia, Maryland and Delaware. The best was yet to come!

From the tops of two ski slopes close to the plaza, 100 torches crested the ridges in the darkness, parading across and down the slope. When they had formed 2 lines from the top to the bottom of the slopes and after a crescendo of music, the Olympic Torch crested the top of the highest slope and paraded downwards between the two lines. Reaching the bottom of the slope, the skier with the torch paraded to a small, diminutive athlete at the base of the 8 foot tall Olympic Caldron. The Athlete grabbed the torch, scampered up the steps and standing on her tip toes lit the Caldron to thunderous applause.

The Opening Ceremony concluded with a 45 minute fireworks display, donated by Zambelli Fireworks.

Special Olympics Winter Games (continued)

While proud to represent the State Knights of Columbus, along with State Deputy Mark Jago, I still have some concerns about the Donation that the State Council will make in June. While some Councils starting to send donations to the State Council to be passed on to the State , Special Olympics, our total donation is still under \$7,000. We want to donate at least \$50,000 to State Special Olympics and this takes effort from all 525 Councils not just a handful. R

In February, I challenged 93 District Deputies to motivate their Councils to raise funds for the State Special Olympics, suggesting that the “Big Dog” Councils raise \$2,000 each for State Special Olympics by March 31st and that the other Councils in each District support Special Olympics as best they can. 

St. Joseph the Worker Council Organizes a Blood Drive



In the fall of 2010, Monsignor Robert Wargo asked St Joseph the Worker Council 10921, Orefield to organize blood drives on behalf of the parish. The council embraced the challenge and has organized parish 19 blood drives. The council works very closely with Miller Keystone Blood Center (MKBC) to make each drive a successful event. The numbers speak for themselves. St Joseph the Worker donors have donated 2135 pints that has helped save over 6300 lives in the greater Lehigh Valley.

The last parish blood drive was held on February 23rd to help a 4-year-old preschool student at the parish school who has been diagnosed with leukemia. The turnout was tremendous with 105 pints collected, the best collection day in the last ten years for the parish's regular blood drive.

The council does more than just advertise the blood drive in the parish bulletin. A number of members and their families regularly donate at the drive and MKBC collection centers. In fact, one member, Ron Paff, has donated over **100 gallons**. In addition, Knights and their wives speak at all of the masses the weekend prior to the drive and sign up donors after mass. When the MKBC truck arrives at the parish at 6 AM on the day of the drive, Knights are there to assist with unloading the truck and setting up to make sure the drive starts on time. Knights are there to assist during the drive, whether it is to make coffee or adjust the room temperature, whatever MKBC needs. When the drive is finished, Knights are there to pack up and load the truck after a long day. See Pictures below:
